## Certification

The asbestos removal sector is regulated and monitored by the Health & Safety Executive (HSE) and other specialist organisations. Our staff are highly trained, with continuing professional development to ensure they remain up to date with any changes to industry best practice.

### ◆ ISO 9001 Quality Management Certification

Westland Environmental holds the BE EN ISO 9001 quality management standard, which underpins our approach to continuous improvement. ### ◆ Fortnum & Mason *Invicta Analytical Services*

**Value: £20,000**

**Project Duration – 4 weeks**

## Case Studies 3 & 4

### ◆ Private Residential Manor House *Kettlebrook Construction*

Value: £7,000

Project Duration – 10 weeks
